The American Occupational Therapy Association in collaboration with the Committee on Allied Health Education and Accreditation of the American Medical Association is officially recognized as the accrediting agency for **entry-level** educational programs for the occupational therapist and the occupational therapy assistant in the United States and its territories. (On June 19, 1993, the Representative Assembly of the American Occupational Therapy Association voted to establish an independent accrediting agency, expected to be operational in 1994.) The Council on Postsecondary Accreditation and the U.S. Department of Education require that a list of accredited educational programs be published annually.
