The AOTA Accreditation Council for Occupational Therapy Education (ACOTE®) met in February 2021 and took the following accreditation actions:

<u>Inactive Status</u>: Inactive status is a special status applied only to programs that are **not currently enrolling new students** and do not plan to enroll new students in the future. The status "inactive" does not replace any other current accreditation status. The designation follows the regular accreditation status (e.g., Accreditation—Inactive or Probationary Accreditation—Inactive). Students graduating from a program with Accreditation—Inactive or Probationary Accreditation—Inactive status are considered graduates of an accredited program.
