

Accreditation Visits Scheduled for Winter-Summer 2020

As required by the United States Department of Education, this serves as notice to the public of upcoming accreditation visits and an opportunity for written third-party comment. Per ACOTE's [Policy on Third-Party Comment](#), AOTA accreditation staff will acknowledge receipt of the third-party comment and will copy the letter of comment to the relevant program director and on-site evaluation team. The individual making the third-party comment may request in writing to remain anonymous. AOTA staff will redact personal information contained within the document prior to forwarding the comment to the program director and the on-site evaluation team.
